Said assessment roll has been prepared for the purpose of assessing all or a portion of the costs of the construction of the Project incidental thereto within the aforesaid Lake Oak Farms Subdivision (No. 1 and No. 2) Special Assessment District, as more particularly shown on the plans on file with the Township Clerk at 10001 Silver Lake Road, Brighton, Michigan within the Township, which assessment is in the total amount of \$426,700.

However, appearance and protest at the public hearing on the special assessment roll are required in order to appeal the special assessment to the Michigan Tax Tribunal. An owner or other party in interest or his or her agent may (1) appear in person at the hearing to protest the special assessment, or (2) file his or her hearing appearance or protest by letter before the close of the hearing.

PLEASE TAKE FURTHER NOTICE that the said Special Assessment Roll may be examined at the office of the Township Clerk, 10001 Silver Lake Road, Brighton, Michigan during regular office hours from the date of this Notice until and including the date of the public hearing hereon and may further be examined at such public hearing.

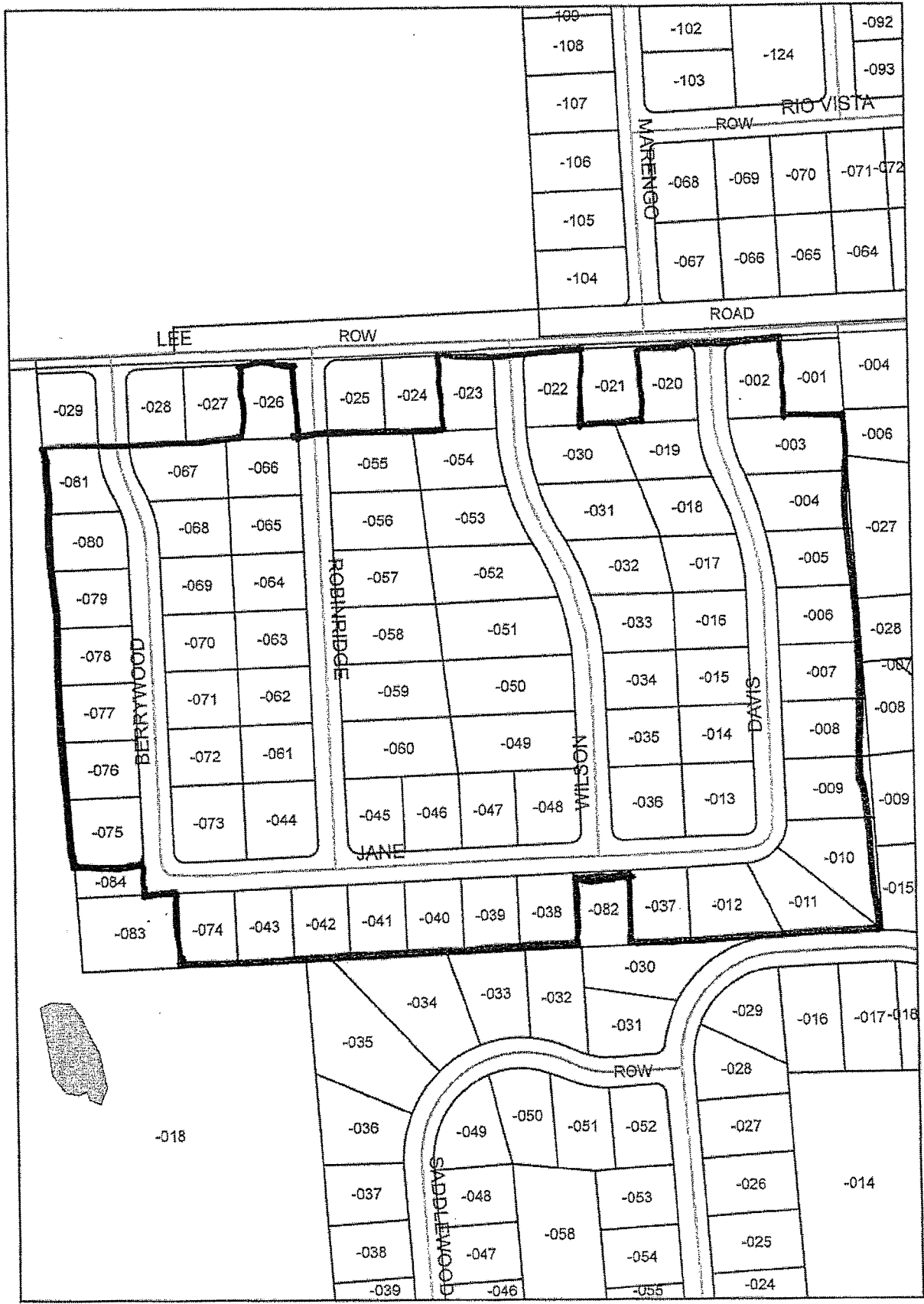
