This item is used for the installation of a heating system in a **new residential structure**. Items #15, Gas Piping; #11, Duct; and #37, Rough inspection, **SHOULD NOT BE** charged. Replacement systems should be itemized.

**ITEM #4, RESIDENTIAL BOILER:**

A residential boiler must be installed by a licensed boiler installer.

**ITEMS #14 and #15, TANKS:**

A homeowner must own tank to install. If homeowner does not own tank, a licensed mechanical contractor must install tank.

**IX. Instructions for Completing Application**

**GENERAL:** Mechanical work shall not be started until the application for permit has been filed. All installations shall be in conformance with the State Mechanical Code. **No work shall be concealed until it has been inspected.** When ready for an inspection, call the inspector providing as much advance notice as possible. The inspector will need the job location and permit number.

**EXPIRATION OF PERMIT:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CANCELLED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CANCELLED PERMITS CANNOT BE REFUNDED OR REINSTATED.**
